

# masjidsinfo.com - Privacy Policy

## 1. Introduction

This Privacy Policy describes how [masjidsinfo.com](https://masjidsinfo.com) (the "Platform," "we," "us," or "our") collects, uses, and shares personal information of users ("Users" or "you") who visit or use our website, [masjidsinfo.com](https://masjidsinfo.com). We are committed to protecting your privacy and ensuring the security of your personal information in accordance with the Lei Geral de Proteção de Dados (LGPD) and other applicable laws.

## 2. Information We Collect

**2.1. Information You Provide Directly:** When you register on our Platform, we collect the personal information you provide, such as your name, email address, and phone number. This information is used to authenticate your account and enable you to subscribe to masjids and receive updates.

**2.2. Usage Data:** We may collect information about how you use the Platform, such as the masjids you subscribe to, the features you use, and the dates and times of your activity. This data helps us understand how users interact with the Platform and improve our services.

**2.3. Technical Information:** We may automatically collect certain technical information about your device and internet connection, including your IP address, browser type, operating system, and device identifiers. ## 3. How We Use Your Information

3.1. We use the personal information we collect for the following purposes: a. **Account Management:** To create and manage your user account, verify your identity, and provide you with access to the Platform's features. b. **Communication:** To send you updates, news, and event notifications from the masjids you have subscribed to. We may also use your email address or phone number to communicate with you regarding your account or important Platform updates. c. **Platform Improvement:** To analyze usage patterns and trends, personalize your experience, and improve the functionality and content of the Platform. d. **Security:** To protect the security and integrity of the Platform and to prevent fraud and unauthorized access. e. **Customer Support:** To respond to your inquiries and provide support.

## 4. Legal Basis for Processing Personal Data (Under the LGPD)

4.1. We will process your personal data based on one or more of the legal bases provided under the LGPD, which may include: a. **Consent:** Where you have given us your explicit consent to process your personal data for specific purposes (e.g., receiving certain types of communications). You have the right to withdraw your consent at any time. b. **Legitimate Interest:** Where the processing is necessary for our legitimate interests, provided that such

interests are not overridden by your fundamental rights and freedoms (e.g., improving the Platform, ensuring security). c. **Performance of a Contract:** Where the processing is necessary for the performance of a contract to which you are a party (e.g., providing you with the services you requested upon registration). d. **Compliance with a Legal Obligation:** Where the processing is necessary for compliance with a legal obligation to which we are subject.
