

masjidsinfo.com - Terms of Service

1. Acceptance of Terms

By accessing and using the masjidsinfo.com website (the "Platform"), you ("User" or "you") agree to be bound by these Terms of Service ("Terms"). If you do not agree to these Terms, you may not access or use the Platform.

2. User Registration

2.1. To access certain features of the Platform, such as subscribing to masjids and receiving updates, Users may be required to register for an account.

2.2. During the registration process, Users will be asked to provide certain personal information, including their name, email address, and phone number. You agree to provide accurate, current, and complete information during the registration process and to update such information to keep it accurate, current, and complete.

2.3. You are responsible for maintaining the confidentiality of your account credentials and for all activities that occur under your account. You agree to notify us immediately of any unauthorized access to or use of your account.

3. Masjid Subscription

3.1. Once registered and verified, Users can subscribe to specific masjids listed on the Platform to receive news, events, and other updates related to those masjids.

3.2. By subscribing to a masjid, you consent to receive communications from the Platform regarding that masjid. You can manage your subscriptions and communication preferences through your account settings.

4. Management of Masjid Data

4.1. The masjidsinfo.com team ("Masjids Info Team") is responsible for the initial selection and authentication of Users who will be authorized to manage masjid data on the Platform.

4.2. Selected Users, authenticated by the Masjids Info Team, will have the ability to update, create, and manage information related to specific masjids on the Platform. The Masjids Info Team will determine the scope of these management permissions.

4.3. Selected Users may also have the option to add sub-administrators to assist in managing the updates of the masjids they are responsible for, subject to the Platform's functionalities and the Masjids Info Team's guidelines.

4.4. Deletion of Masjid Data: Any request to delete a masjid's data from the Platform must be submitted to the Masjids Info Team for validation and approval before the deletion is carried out. This process is in place to maintain the integrity and accuracy of the Platform's content.

5. Masjid Data Approval Process

5.1. All masjid data submitted or updated by Selected Users and their sub-administrators will be subject to an approval process by the Masjids Info Team.

5.2. The Masjids Info Team will use reasonable efforts to review and approve masjid data to ensure its validity, accuracy, and appropriateness, as much as reasonably possible. However, masjidsinfo.com does not guarantee the absolute accuracy or completeness of all masjid data on the Platform.

6. User Data Deletion

6.1. Users have the right to delete their personal data from the Platform if they wish to leave. Upon a user's request for account deletion, masjidsinfo.com will take reasonable steps to remove their personal information from our active databases, subject to any legal obligations to retain certain data.

7. Termination of Accounts

7.1. masjidsinfo.com reserves the right to suspend or terminate your account and access to the Platform at any time, with or without cause, and without prior notice, including but not limited to: a. Violation of these Terms. b. Inactivity for an extended period. c. Engagement in conduct that masjidsinfo.com, in its sole discretion, believes is harmful to the Platform, other users, or our business interests. d. Requests from law enforcement or other government agencies.

7.2. Users may also terminate their accounts at any time through the account settings or by contacting us directly.

7.3. Upon termination, your right to use the Platform will cease immediately. Sections of these Terms that by their nature should survive termination (such as Intellectual Property, Disclaimer of Warranties, and Limitation of Liability) will continue to apply.
